



GENERAL INFORMATION on JONKER ABELN

Jonker Abeln ('the Firm') is the commercial name under which George A. Offerhaus now runs the law practice formerly belonging to the partnership Jonker Abeln Advocaten. He is bound by all statutory and conventional rules for *advocaten* in The Netherlands and in Europe, which include professional secrecy and disciplinary rules. His registered specialization is business law. Based on this registration, he is required to obtain ten training credits per calendar year in this area in accordance with the standards set by the Netherlands Bar.
